

**ALBION CITY COUNCIL  
SPECIAL MEETING  
NOVEMBER 10, 2008  
12:00 P.M. CITY HALL**

A Special meeting of the Mayor and Council of the City of Albion, Nebraska was convened in open and public session at 12:00 P.M., on November 10, 2008 at Albion City Hall. Present were: Mayor Jarecki, Councilmembers Cox, Rasmussen, Riedmiller, also present was: City Clerk Devine, other present was Don Casper of Albion Thriftyway. Notice of this meeting was simultaneously given to the Mayor and all members of the Council and a copy of their acknowledgment of receipt of the notice is attached to these minutes. Availability of the agenda of this meeting was communicated in advance notice to the Mayor and Council. Notice of this meeting was given in advance by publication, a designated method for giving notice, a copy of publication being attached to these minutes. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

4. Councilman Riedmiller made a motion to table approval of the minutes of the October 14, 2008 meeting until the November 18, 2008 regular meeting, seconded by Rasmussen. **Vote: Yeas; Cox, Rasmussen, Riedmiller. Nays; None. Absent; Hoefer.**
5. Councilman Cox made a motion to approve the application of Albion Thriftyway for special designated alcohol license, seconded by Rasmussen. **Vote: Yeas; Rasmussen, Cox, Riedmiller. Nays; None. Absent; Hoefer.**
6. Councilman Cox made a motion to approve the application of Jason Borer to the Albion Volunteer Fire Department, seconded by Riedmiller. **Vote: Yeas; Rasmussen, Riedmiller, Cox. Nays; None. Absent; Hoefer.**
7. Councilman Rasmussen noted that the Engine Brake ordinance seems to be violated often. Devine will look into this administratively, but it may be placed on future agenda if further council action such as an ordinance change is necessary. The next regular meeting is November 18, 2008 at 7:30 p.m.
8. At 12:04 p.m. Councilman Rasmussen made a motion to adjourn, seconded by Cox. **Vote: Yeas; Riedmiller, Cox, Rasmussen. Nays; None. Absent; Hoefer.**
